**COURSE DESCRIPTION:**

**This course will include a comprehensive overview of the Reformation Era, including: the critical movements of Catholic reform during the Middle Ages; the central Reformation movements encouraged by figures such as Erasmus, Luther, Zwingli and Calvin; the special circumstances of the English Reformation(s) and the spiritual renewal of the Counter-Reformation.**

**CLASS OBJECTIVES:**

Students should:

- 1) Develop methods for understanding and analyzing primary and secondary sources.
- 2) Acquire the methodology needed for writing analytical research papers.
- 3) Develop the ability to identify various types of historical documents and determine where sources of historical research are to be found and how they are to be used in the study of the discipline.
- 4) Discover how art, architecture and literature may be used to understand history and theological thought more profoundly and examine their interdisciplinarity.
- 5) Empower and inspire students to continue the study of history with the confidence that comes from a greater knowledge of the material and from the academic skills needed to delve deeply into various aspects of Catholic Church life.
- 6) Challenge pre-conceived notions about the history of the Catholic Church and other Christian Churches in the Reformation Era, and provide an opportunity to encounter diverse perspectives and opinions.
